A resolution of the Board of Commissioners of _____ County Fire Protection District No. _____, providing for the submission to the qualified electors of the district at an election to be held within the district on _____ (date), of a proposition authorizing the levy of a regular property tax in the sum of \$.50 (maximum) per \$1,000 assessed valuation each year for _____ (six or ten) consecutive years beginning in _____ (year) to be collected in _____ (year) for the provision of emergency medical services all as provided in _____ County Fire Protection District No. _____ Resolution No. _____ and the laws of the State of Washington RCW 84.52.069.

WHEREAS: It is the judgement of the Board of Commissioners of the district that it is essential and necessary for the protection of the health and life of the residents of the district that the emergency medical services enumerated in this resolution be provided by the district. Such services will necessitate the expenditure of revenues for maintenance, operations and equipment.

NOW, THEREFORE BE IT RESOLVED by the Board of Commissioners of _____ County Fire Protection District No. _____, as follows:

SECTION 1. That the district shall provide emergency medical care or emergency medical services, including related personnel costs, training for such personnel, and related equipment, supplies, vehicles and structures needed for the provision of emergency medical care or emergency medical services.

SECTION 2. In order to produce the revenue adequate to pay the costs of providing life protection services as described in Section 1 of this resolution and to maintain reserve funds sufficient to assure the continuation of such services, the district shall levy for _____ (six or ten) consecutive years beginning in _____ (year), and collected in _____ (year), a general tax on taxable property within the district, maintenance and operation costs in the amount of \$ _____ per \$1,000 of assessed valuation.

SECTION 3. There shall be submitted to the qualified electors of the district for their ratification or rejection at an election on _____ (date) the question of whether or not such levy for maintenance and operations shall be made.
